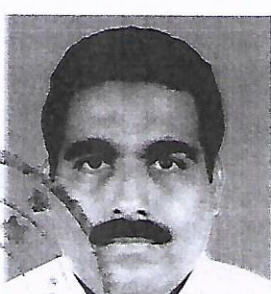

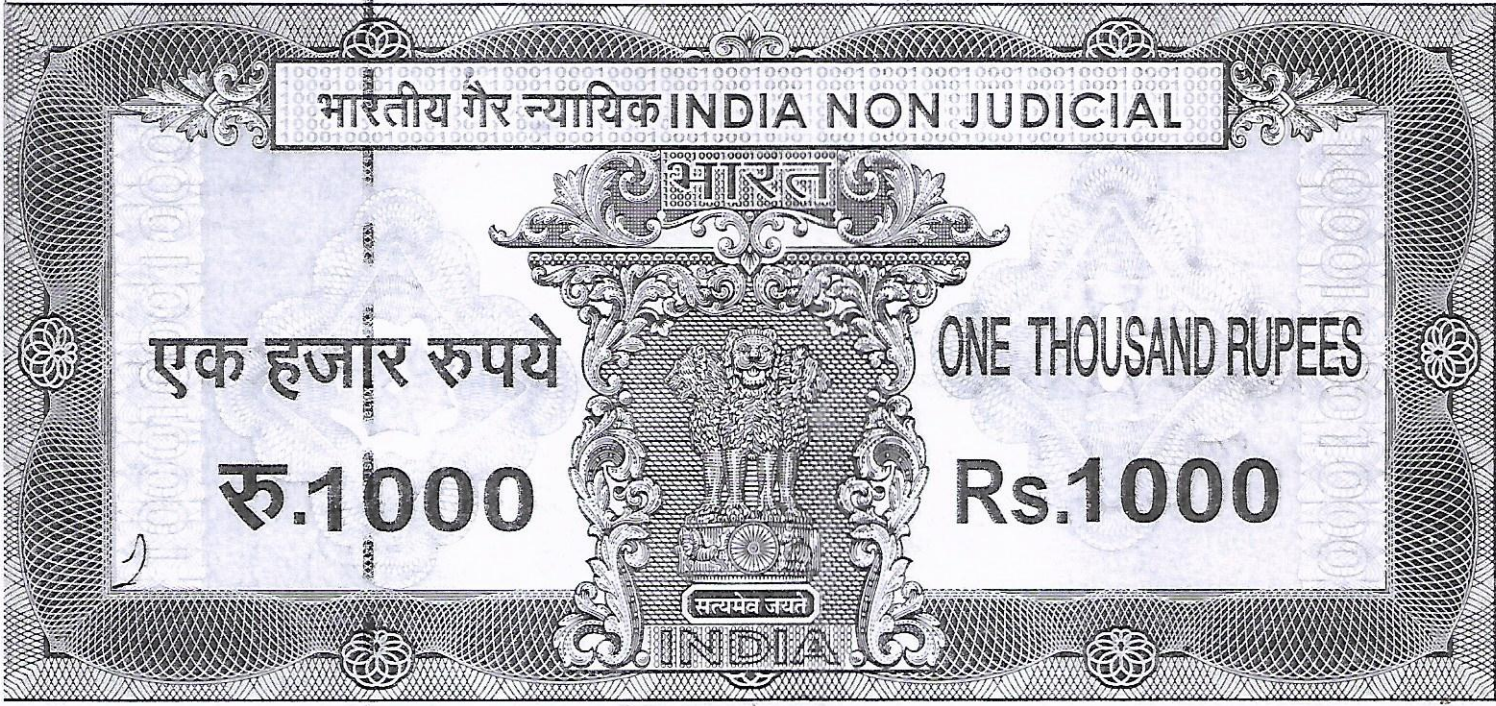

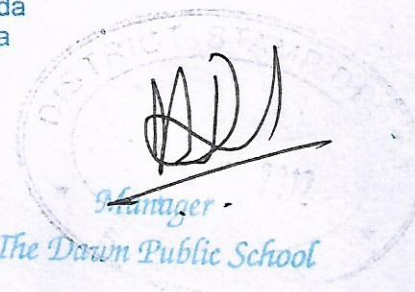

The following may be added as clause 7 in page 6.

The benefits of the trust shall be extended to the public irrespective of caste, creed and colour, primarily for the muslim community.

Page 10: Before the clause "Bank Account", the following shall be added:

There shall be an executive committee for the trust. The executive committee shall consist of not more than 11(eleven) members elected by the trustees from among the trustees. The executive committee shall be in charge of the day to day administration of the trust. The office bearers of the trust shall be members of the Executive Committee. The Chairman, Secretary and Treasurer respectively shall be the Chairman, Secretary and Treasurer of the Managing Committee of the Institutions under the Trust.


This Deed of Amendment shall form part of and be read as part of the original Trust Deed No. 11/2002 dated 11.01.2002.


